MINUTES OF 113th ANNUAL GENERAL MEETING

June 11, 2018

The 113th Annual General Meeting of the Kingston General Hospital Auxiliary was held on Monday June 11, 2018 at Minos Restaurant, Kingston. There were 37 members and 13 guests present.

1. CALL TO ORDER & ADOPTION OF THE AGENDA

The President, S. Fletcher, called the meeting to order at 11.00 a.m. and welcomed everyone. An addition to the agenda listed in the program was pointed out in that a motion was omitted under the Treasurer's report. The motion is included in the agenda listed in the Annual Report on Page 3. 6.6 P. Ginn moved, seconded by J. Fraser, that KPMG Chartered Accountants be appointed as Auditors for the KGHA for the Fiscal Year April 1, 2018 to March 31, 2019. Motion carried. Denise Cumming thanked the KGH Auxiliary for their donation and pledge toward the redevelopment of the KGH site. The new facilities created will greatly enhance patient care and the work of KGH staff.

7. ANNUAL REPORT

The President presented the Annual Report and thanked the Auxiliary Assistant, Theresa Hill, for the work involved in preparing the report and thanked KHSC Printing department for its work in its presentation. Acceptance of the Report as printed was moved by B. Heeney, seconded by B. Arniel. Motion carried. 8. LUNCH - The meeting adjourned at 11:30 a.m. for lunch.

The meeting reconvened at 1:15 p.m.

He thanked the Auxiliary for their support of the redevelopment which will be a huge benefit to the Kingston Region. He communicated that the Ministry of Health and the City of Kingston were impressed with how well the plans for the redevelopment and integration had been organized and implemented.

PRESIDENT'S ANNUAL REPORT

One of the big changes for our Auxiliary was the demise of HAAO as of November 2018 with the effect of also eliminating the Region conferences. Thus we will no longer be paying an annual fee to HAAO for membership, will not be attending the annual HAAO convention or Region conferences and there will no longer be any candidates for a Provincial Life Membership.

Financially speaking, we have had an extremely successful year. Our ongoing retail businesses continue to generate a healthy income while serving the needs of everyone who works, visits, and/or volunteers at the hospital. We are fortunate to have two very capable and highly qualified managers who make running their respective businesses look easy and who report to their own Committees, each under the guidance of a volunteer Convenor. Our Café manager continues to provide appetizing daily specials using available local food and produce. Thanks partly to the introduction of the Credit/Debit card machine, sales in the Café this year have increased and this has enabled us to not only cover the balance of the cost of the renovation of the space but to exceed the amount we budgeted to turn over to the Auxiliary. Thankfully the renovation was completed on time and on budget. The new display cases are bright and pristine which makes the goods on offer look even more appetizing and appealing. Although the work space behind the counters has a different configuration, our amazing and skilful staff, some of whom have been with us for 25 years or more, have coped admirably.

Our Gift/Tuck Shop sales were also over and above expectations. The Gift Shop has items for the home, lingerie, dresses, casual tops, purses, Canadian made jewelry and many sundry items useful to patients and visitors. In the Tuck Shop we offer really great coffee as well as flavoured coffees – Irish Cream, Caramel Biscotti, and Hazelnut. Our muffins, pastries and sandwiches are delivered fresh daily by the Golden Rooster and have proved so popular that we are sold out early most days. The Tuck Shop also has used books for sale at a very low cost as well as sundry items, greeting cards, newspapers and, of course, a wide assortment of candy, chips, gum, granola bars and health and soft drinks.

Another business is our Hair Salon on Connell 1 which is open two days a week, Thursday and Friday. It serves patients, visitors and staff at very reasonable prices and provides a valued service to all. Refurbished wigs are available to cancer patients at a very reasonable cost. We are always looking for donations of gently used wigs which the hair stylist refurbishes.

HELPP lottery sales in the Abramsky Lobby are steady but more volunteers are still needed. Our Lottery Booth, adjacent to the Tuck Shop on Connell 1 is open five days a week and this year generated \$20,000, which again was more than expected. Large jackpots have contributed to this excellent outcome.

Other fundraising events this year included Luncheon and Bridge events in October and April, the annual theatre trip to Stratford in June and the Christmas Bazaar in November. The 2018 Teddy Bear Campaign raised \$32,000 with 300 large bears being "sponsored". Please check out the Fundraising section later in this report for details.

KGH Auxiliary does not just raise money. With the help of the Social Work department, we also maintain and operate the Family Services area. This is well used and continues to receive positive feedback and great donations from appreciative families who can stay overnight in the unit at no cost to be close to their critically ill family member. Special Care volunteers visit many patients at KGH, including palliative ones, on a regular basis. The Coffee Cart and Library Cart continue to be appreciated by both patients and visitors alike in waiting rooms. Our HUGS program supplies every baby born at KGH with a small gift bag of useful items for the new baby and larger bags are given to those parents who have a greater need. Everything in the bags is supplied by our generous donors.

I have enjoyed working for the Auxiliary over the year and will continue to do so in the future in any capacity required. We are lucky to have such dedicated and faithful volunteers and staff. Without them, we would not be able to achieve our goals. Thank you to all!

ARTISTIC OUTREACH

Artistic Outreach continues to be a popular program with patients at KGH.

Launched in 2006, our group purchased a variety of artwork which was placed in patients' rooms on floors Kidd 9, Kidd 4, Connell 9 and Connell 3.

Volunteers visit with the patients on a regular basis and if they would like the picture changed, we try to accommodate them from our large supply of poster art on our art cart located on Connell 4.

AWARDS

The Awards Committee met in late January to consider recipients for this year's awards as well as to consider how to move forward regarding certain awards after the disbanding of HAAO. Some decisions were finalized via email messages.

This past November at the HAAO Annual Meeting this organization was disbanded as a result of the inability to find members willing to take on the necessary leadership roles. Subsequently our Eastern Ontario Region was polled and their Boards also decided that there was not sufficient interest for the eight member Auxiliaries to continue meeting. This has left Auxiliaries in Ontario without an important award that is given annually to deserving members, the Provincial Life Membership. This pin and the Outstanding Service pin our Auxiliary awards annually came from HAAO. The PLM award was awarded to chosen members at the HAAO Annual Convention in November

after the recipients were announced at the KGHA Annual Meeting. In future, both awards will be given at the KGHA Annual Meeting.

The Awards Committee unanimously decided to recommend continuing to give both awards, to keep the same criteria and to replace the pins. A new name was also decided on for replacing the PLM award. This award will now be called "Award of Merit." The recommendation from the Committee was forwarded to the Board and the Board agreed to this recommendation. New pins have been designed and ordered.

I would like to thank the members of the Awards Committee for their advice and diligence in their consideration of award recipients as well as their wisdom and enthusiasm regarding keeping the two awards as we move forward post HAAO. <u>CAFÉ</u>

Last August saw the fulfillment of a long held dream by the Café staff and Auxiliary members. After years of saving and making plans, the renovation of the Café was completed. Our thanks go to Cupido construction and the hospital planning group especially Erin Eardley who kept a keen eye on the construction and gave advice when needed. Our thanks to our Café manager who helped plan the layout and worked diligently on site to make sure that every aspect and nuance was carried out. The Café staff had a two week holiday away from the kitchen and when they

returned, things were quite different. Their patience and good humour were needed to get used to the smaller space and a new configuration of the kitchen.

Due to our attractive displays of food and a new debit/credit machine, business has increased quite a bit. Our staff is now working to provide customers with over twenty dozen eggs a day, forty loaves of bread and six dozen muffins baked fresh daily. The need for more cheesecakes that are made from scratch in our kitchen and Jello desserts have kept the staff busy. Pizza day and Taco Salad Day are still very popular as well as all the other daily specials that are made with quality and tasty ingredients. Salads and sandwiches made by our staff continue to move well.

Thanks to our Café Committee who meets with our Café Treasurer and Café Manager to vote on needed expenditures and problem solve issues where needed.

Our volunteer Host/Hostess role is primarily used at the busy lunch hour. Keeping tables clean and the front of the Café tidy and well stocked with supplies is appreciated by customers who are looking for a well maintained place to eat their lunch. Thank you.

FAMILY SERVICE

The Family Services Area, which is located within the hospital, provides temporary accommodation free of charge for families of critically ill patients. This service is provided by the Auxiliary and is monitored by a committee which meets on a regular basis. This Committee provides tea, coffee and cookies, makes sure the rooms are comfortable and the washrooms are stocked with soap and shower caps. The area consists of nine rooms and two kitchenettes, one of which has a refrigerator where family members can store food. There have been several requests for a microwave but this is deemed a fire hazard by the hospital safety committee. Last year \$894.54 was spent on supplies and \$2836.54 was donated to the Auxiliary by grateful family members. The occupancy rate was slightly lower than last year at 84%.

KHSC is very supportive of this area and one of the showers was completely renovated two years ago and the cost of renovating the second shower has been approved. Several chairs from the Abramsky Lobby were brought up to replace the fabric covered chairs in the public area. This service has been in operation since in May 1993.

FUNDRAISING

Our fundraising projects this year produced a profit of \$32,500.

The Christmas Bazaar, held November 28, on Connell 3 brought in a record profit of \$7,020. The Bazaar is a popular event with both staff and patients who enjoy browsing, shopping for books, jewelry, home baking, toys, and holiday decorations and/or bid on the many special items in the Silent Auction.

It takes many volunteers to produce such excellent results and we thank all who participated; workers, telephone committee, bakers and donors. Thanks also to Environmental Services who helped so efficiently with set up and clean up,

Terry Walker Manager of Dietary 3 Allergy Study Unit and special thanks to Theresa Hill for her tireless efforts on our behalf.

Other fundraisers included The Spring Fling Luncheon and Bridge, held April 12, 2018 at Cooke's Portsmouth United Church and our popular bus trip to the Stratford Festival in June to see two excellent plays - "The Music Man" and "An Ideal Husband". In November we held our second Teddy Bear Bridge at the Kingston Bridge Centre. A total of \$500 went to The Teddy Bear Campaign.

The Field Of Miracles Mural, located on Davies 5, honouring a child's birth at KGH, is an ongoing fundraiser. The mural, initiated in 2004, continues to prosper under the direction of and with the dedication of Judy Strahan. At the end of 2018 there were a total of 524 plaques on the mural.

Under the leadership of co-Chairs, Heather Breck and Alice Robertson, the 2018 Teddy Bear Campaign raised nearly \$34,000 to purchase a Carescape V100 monitor, weigh scales and opthalmoscopes for pediatric patients at the KGH site of KHSC. Over 350 large and small bears have been delivered to several departments at KGH that support pediatric needs including, Child Life, SADV, Emergency, NICU, Kidd 5 Maternity, and Burr 4 Adolescent Psych. In addition, bears were donated to 'Kids Inclusive' at the HDH site and to Weeneebayko General Hospital in Moose Factory.

We again welcomed the financial support of the Royal Canadian Legion Branch 560 and we are pleased to report that they will be financial partners for the 2019 Campaign. With their generous donation of \$4500 we were able to cover all the expenses of the Campaign allowing us to direct one hundred percent of bear sponsorships to the fundraising goal.

We are grateful for the support of members of the community who continue to sponsor bears and for the generosity of fundraisers at local high schools, KGH Summer Volunteers, and the Photos With Santa team who made large contributions.

A special addition to this year's campaign was a donation of a 13-foot tree for the Abramsky Lobby. We thank the McCullough family for their generosity and their assistance in transforming this tree into a wonderful attraction for the Lobby. We were able to promote the Campaign by adding seasonal decorations and Teddy Bears, and honour the memory of Mariesa and Esterina.

New bears have already been received for the fall and the Committee will meet in September to organize the 2019 Campaign.

LOTTERY BOOTH

The Lottery Booth had a good year in fiscal 2018/19. Sales and commissions increased more than 16% over the previous year, for a profit of \$23,414.06 before expenses (mainly parking) giving a net profit of \$20,588.78. Interestingly, while the increase was the same for both instant (scratch) tickets and on-line tickets, for the former it was due to a shift towards higher-priced products while the latter was due to greater sales volume, predominantly of Lotto Max. This trend may continue in 2019 as Lotto Max goes to a twice-a-week draw.

As always, I thank the volunteers who have contributed so much to maintaining our five day-a-week operation. I particularly salute those who filled in with many extra shifts this past winter when a number of people were sidelined by illness or other absences. We appreciate your dedication. Special thanks go to Theresa Hill who bears the brunt of the rescheduling to manage such disruptions.

With the help of our Volunteers we were able to transfer not only the \$17,000 forecast in last year's budget, but an additional \$3,000 for a grand total of \$20,000 to the Auxiliary General Fund. Finally, I note that we do have some volunteers who are reducing their hours so we will be actively looking for new volunteers to join our team.
