August 2023

The Ministry of Health has confirmed funding for the SE IPAC Hub through the 2023/24 fiscal year. We are pleased to be able to continue working with key partners in Congregate Livings Settings to support strengthening IPAC programs.

Our hub team is transforming, and we are excited to share our team is successfully rebuilding capacity. By September, there will be a total of 7 Clinical Coordinators supporting the hub in various roles across HPE, KFL&A and LGL. Please welcome our newest members!

Emily Moslinger holds a Master of Science degree from Queen's University, and is currently completing her Master of Public Health with an IPAC Specialization from Queen's University. Emily has also worked at Kingston Health Sciences Centre in various health care roles.

Point of Care Risk Assessment

Recently updated guidelines from the Ministry of Health discuss Point of Care Risk Assessments. To bring this practice into focus, resources are linked below which discuss the routine practice of an individual assessment that establishes the risk of transmission, with further consideration given to the personal protective equipment (PPE) to use. This PPE identified by the assessment provides additional protection in reducing personal risk from an interaction with a client/patient/resident.
