About the Long-Term Care Certification in Infection Prevention (LTC-CIP)

According to the Centers for Disease Control and Prevention (CDC), long-term care homes provide a variety of services, both medical and personal care, to people who are unable to live independently. Examples of long-term care settings include:

- nursing homes
- skilled nursing facilities
- assisted living facilities

Eligibility Criteria

- Responsibility for IPAC in LTC
- Post-secondary education in a health-related field (nursing, laboratory, technology, public health or biology)
- Recommended one year FT IPAC experience

Infection prevention activities must include:

- 1. Identification of infectious disease processes
- 2. Surveillance and epidemiologic investigation
- 3. Preventing and controlling the transmission of infectious agents
- 4. Environment of care
- 5. Cleaning, disinfection, asepsis, and sterilization best practices

AND at least two (2) of the three (3) components:

- 1. Employee / occupational health
- 2. Management and communication
- 3. Education and research

Candidates will be required to submit the following documentation with their application:

- Signed <u>Attestation Statement</u> (to be filled out by the candidate's supervisor/employer, please note, this is not the same form used for CIC)
- Proof of Degree (copy of transcript or degree/diploma)
- \$410 examination application fee
